# THIS PRODUCT HAS BEEN MANUFACTURED AND TESTED TO THE HIGHEST QUALITY STANDARDS BY STRUXURE

This Limited Lifetime Warranty offered by StruXure Outdoor, LLC - "StruXure" covers defects in material for a new Cabana X system. This warranty extends to the original purchaser and may be transferred to new owners via procedures included herein. This warranty only covers StruXure products purchased from StruXure or Authorized StruXure Dealers. This warranty is subject to limitations, exclusions, and conditions as detailed in this Warranty Certificate.

Cabana X offers a Limited Warranty on its aluminum frames, motorization, and curtain fabric to the original buyer at the original delivery address against defects in material or workmanship for the following durations:

- / Aluminum Frame (Post/Beam/Louver) Warranty: 5 years on materials
- / Motorization Somfy® Warranty: 5 years on materials
- / Fabric Warranty: 5 years on materials

Defects in workmanship and materials are defined, for the purpose of this warranty, as causing the product to be unsound structurally or mechanically, or substantially altering the appearance of the Cabana X. A valid proof of purchase receipt for your Cabana X will be required to make any Warranty claim.

Any modifications made to the Cabana X by or on behalf of the customer, or the use of chemical treatments or improper cleaning invalidates the Warranty.

We will repair or, at our discretion, replace all or any part of the Cabana X if we determine that it is necessary in order to provide you the best Cabana product on the market. Should repair or replacement be necessary, photographs demonstrating reasons for repair or replacement is required. Please contact Cabana X for an inspection promptly after receiving the product if a problem is evident. This Limited Warranty includes a one (1) year warranty for labor. To file a Warranty claim or to report any problem, send an email to Support@CabanaX.com A valid proof of purchase receipt for your Cabana X will be required to make any Warranty claim.



## Warranty does not cover:

/ Failure caused by lack of appropriate care and maintenance
/ Damage due to misuse or improper assembly
/ Use of improper cleaning products, sun-tan oils, or chemicals
/ Mold or mildew
/ Damage due to vandalism, pets, or rodents
/ Minor variations in color and texture of finishes
/ Acts of nature (ice, flooding, wind, snow, etc.)
/ Damage caused by exposure to heat or flame
/ Bursting or cracking of framing (Post & Beams) due to exposure to water and freezing temperatures

We have taken great care in designing and building our products to stand up to harsh environments, but nothing is foolproof. Care and maintenance are required to ensure the proper lifetime of your Cabana X. Mildew and mold grow on dirt, pollen, and other organic matter; so simple routine cleanings will prevent them from forming on powder coated aluminum and fabrics. Keep louvers open when not in use and take out and store the louvers in a dry place during the off-season. Extra care is required if the cabana is used by an indoor pool or near the seaside. #### **Fabric Warranty**

In our journey towards excellence, we offer you the highest quality outdoor upholstery that boasts one of the best fabric warranties in the industry. The fabric warranty applies to pieces of upholstered fabric and protects against fabric becoming unserviceable due to color or strength loss from normal usage and exposure conditions, including sunlight, mildew, and atmospheric chemicals.

### Somfy Warranty

Another great partner of ours is Somfy®, the worldwide leader in automation. Somfy® offers qualified original Cabana X purchasers a 5-year warranty on all motors and controls. Specifically, Somfy® warrants its motors and controls to be free from defects in material and workmanship under normal and proper use for a period of 5 years commencing with the date stamped on each product. If the Somfy® product fails within this 5-year period, Somfy® will repair or replace it free of charge through StruXure. Batteries are not covered by the Warranty.

THIS LIMITED WARRANTY IS THE EXCLUSIVE WARRANTY GIVEN BY STRUXURE OUTDOOR, LLC. (CABANA X) AND SUPERSEDES ANY PRIOR, CONTRARY OR ADDITIONAL REPRESENTATIONS. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY STATUTORY WARRANTY OR CONDITION OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE DISCLAIMED EXCEPT TO THE EXTENT PROHIBITED BY LAW. IN SUCH EVENT, SUCH WARRANTY IS LIMITED TO THE DURATION OF THE WARRANTY PERIODS SET FORTH ABOVE. THIS EXCLUSION APPLIES EVEN IF THIS WARRANTY FAILS OF ITS ESSENTIAL PURPOSES AND REGARDLESS OF WHETHER DAMAGES ARE SOUGHT FOR BREACH OF WARRANTY, BREACH OF CONTRACT, NEGLIGENCE, OR STRICT LIABILITY IN TORT OR UNDER ANY OTHER LEGAL THEORY. This Warranty does not apply to any incidental losses or accidental damage or breakage, or for any damage caused by; transporting, dropping, mis-assembly of the Cabana X, any modification or alteration of the assembly of the Cabana X, malfunctions or damage resulting from other than defects in material, structure or system modifications or alterations, negligence, abuse, improper care, normal and reasonable wear and tear, normal weathering, chalking, fading, corrosive atmosphere contaminated with chemical fumes or salt, or any act of God including without limitation, damage from snow, ice, heavy or extreme wind conditions or events, customer's failure to follow the StruXure Safety Instructions and Warnings, storms, or natural disasters.

This Warranty does not cover accessories, connected materials and products, or related products not manufactured and/or supplied by StruXure Outdoor.

This Warranty does not cover scratches, dents, chips, fading, changes in appearance of the components and nonstructural blemishes that do not affect the performance or structural integrity of the Cabana X.



## **Transferring your Warranty:**

This warranty may be transferred to new owners during the life of the Warranty by adhering to the following procedure:

- / Go to www.cabanax.com
- / Submit Warranty registration with the NEW owner information
- In the "Any Comments" section of the warranty submission, please be sure to mention this is for a Warranty Transfer as well as list the original owners contact information.
- There is no charge for this transfer, however StruXure must acknowledge in writing that the new registration has been received.

This Limited Lifetime Warranty only applies to product(s) installed within the United States, Mexico, Canada, and the Caribbean.

### **Notice to Purchaser:**

/ When not using the Cabana X it is recommended that all louvers should be left in the open position.
